Project Location: The Project is located on Colonial Drive, near Ingleside in the Township of South Stormont.

Saturn Power Inc. in partnership with Canadian Solar Solutions Inc. is planning to engage in a renewable energy project for which the issuance of a renewable energy approval is required. The proposal to engage in the project and the project itself is subject to the provisions of the Environmental Protection Act (Act) Part V.O.1 and Ontario Regulation 359/09 (Regulation). This notice must be distributed in accordance with section 15 of the Regulation prior to an application being submitted and assessed for completeness by the Ministry of Environment.

This first Public Meeting is being held to provide initial information on the proposed project. The meeting will be an open house format. You are welcome to attend at anytime during the hours indicated below. A second Public Meeting will be held in late 2010 to provide more detailed information on the proposed project.

Project Description:

Pursuant to the Act and Regulation, the facility, in respect of which this project is to be engaged in, is a Class 3 Solar Facility. If approved, this facility would have a total maximum name plate capacity of 10 MW. The project location is illustrated in the map below.

The Draft Project Description Report titled *Project Description Report for William Rutley Solar Park Proposed Solar Photovoltaic Project* describes the project as a solar electric generating facility that will utilize photovoltaic (PV) panels installed on fixed racking structures. DC electricity generated from the PV panels is converted to AC electricity by an inverter. The voltage level of the AC electricity produced by the inverter is stepped-up to distribution level voltages by a series of transformers.

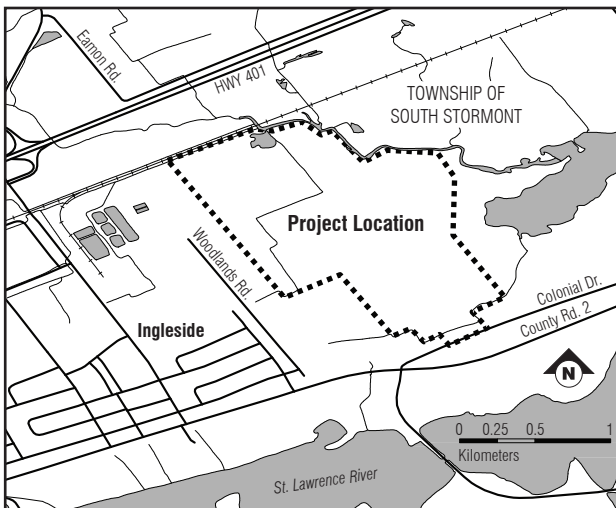
